ELIGIBILITY

MBBS + MS (Ortho.) / DNB (Ortho.) from any recognized University with valid State Medical Council /MCI Registration. Candidate possessing regular/full time qualifications prescribed above is only eligible to apply. In other words, the qualifications acquired through part time/correspondence/distance education/E-learning course are not eligible to apply.

AGE LIMIT:

Upper age limit is 65 Years as on the date of Advertisement. No further relaxation is admissible.

PERIOD OF ENGAGEMENT:

The Specialist will be engaged initially for a period of two years (1 visit in a week), which may be extended further based on the requirement of the Hospital and performance of the Specialist. Performance of the Specialist will be assessed by the Head of the Hospital during the said period. They will be reporting to the Head of the Hospital.
