Further the following are the terms and conditions for engaging Trade apprentices:

- 1- Age limit: The minimum age limit is 18 year and the maximum age limit is 30 years as on closing date (Relaxable by 05 years for SC/ST & 03 years for OBC (None Creamy Layer) & 10 years for 40% PWD candidates (VH/OH/HH) in their category.
- 2- Stipend: As per provisions of Apprentice Act. 1961.
- 3- Training Duration: One Year.
- 4- The defined seats of reservation for SC, ST will be as per Apprentice Act. 1961, in the ratio of 1:6 and 1:3. Reservation for EWS, OBC and PH candidates will be given as per the norms of Uttarakhand Government.
- 5- Preference will be given for candidates from project affected families (PAF) and project affected areas (PAA) of Pipalkoti.

- 7- Candidates should be eligible with respect to age criteria and educational qualification as on closing date. Result awaited candidates need not apply.

- 10-The candidates who after completion of their education have undergone apprentice training in any organization, training or job experience of one or more year shall not be considered eligible for apprentice training.

 - g. Aadhar card (mandatory).
 - h. Certificate of Project Affected Family/project affected area (if applicable).
 - i. Domicile certificate of Uttarakhand state only.
 - j. Registration Number-Printout of registration number generated on www.apprenticeshipindia.org. Portal.
- 13-Those candidates who have successfully completed ITI (Regular) in 2020, 2021, 2022 2023 and 2024 are only eligible for apprenticeship Training. Candidates whose results are awaited (till closing application date) will not be eligible for applying for apprenticeship training.
- 14-The selection and deployment of apprentice trainees will be subjected to the provisions of the Apprentice Act, 1961.
- 15-Candidates may kindly ensure that they possess required qualification for the apprenticeship training, if at any time of joining or after joining apprentices training it is found that candidates have submitted wrong information or the documents
