# TERMS AND CONDITIONS FOR THE RETAINERSHIP OF ADVOCATES FOR CONDUCT OF CRIMINAL CASES ON THE PANEL OF THE OFFICIAL LIQUIDATOR

- 1. The Advocate/Counsel should be registered with the Bar Council of Maharashtra & Goa and should be in active practice in Mumbai;
- 2. The Advocate/Counsel should have at least 10 years of standing at the Bar and 10 years' experience of conduct of trial in Criminal complaint cases;
- No complaint should have been received by the Bar Council
  of Maharashtra & Goa against the candidate, who has
  applied;
- 4. For every date of effective absence, an amount of Rs.1,500/-shall be deducted from the retainership fee;
- 5. Fees structure payable to various category of Central Government Counsel as approved by Ministry of Law & Justice, Department of Legal Affairs Office Memorandum No. 26(1)/2015/Judl. Dated 1st October, 2015 as revised from time to time subject to applicable TDS., subject to applicable TDS shall be paid.

The applicants should furnish the areas in which they have been practicing and the Courts they are attending to, including their area of expertise;
- 7. Retainership term shall be for a period of 12 months starting from the date of appointment, or until further orders, whichever is earlier;

8. Termination of retainership - The retainership of any Advocate/Counsel would be terminable by either side at any time with Notice of one month, without assigning any reason;

### 9. The Advocate shall: -

- i) Appear before Bombay High Court other courts where complaint cases / criminal cases related to companies (in liquidation) are pending;
- ii) Keep the Official Liquidator informed, in writing, about all the important developments in the case from time to time, particularly with regard to drafting, filing of papers, dates of hearing of the case, supplying copies of judgment, etc.;
- iii) Furnish to the Official Liquidator, periodical statements and reports / returns, which may be called for by the Official Liquidator / Hon'ble Company Judge;
- iv) Perform such other duties of legal nature which may be assigned to him by the Official Liquidator from time to time such as drafting, vetting of replies, etc.
- vi) To assist the Special Counsel in the matter, as may be appointed by the Official Liquidator;
- 10. The Advocate/Counsel will have a right to private practice which should not, however, interfere with the efficient

discharge of his/her duties, as a Counsel/Advocate for the Official Liquidator;

- 11.If the Counsel happens to be a part of a firm or associated with a Lawyer or a Solicitor, it will be incumbent on the firm not to take up any case of the Official Liquidator, or any case in Bombay High Court or other Courts arising out of these cases, e.g., appeal and revisions in the High Courts or The Supreme Court.
- 12. Appointment of the Advocates for conduct of Criminal Cases shall be subject to a condition that during the period of retainership with the Official Liquidator's Office, they will not advise any party or act in any case against the Official Liquidator. That subject to the said restriction, the Advocates can take up private brief/assignment which shall not interfere with the efficient discharge of his/her duties as Advocate of the Official Liquidator.
